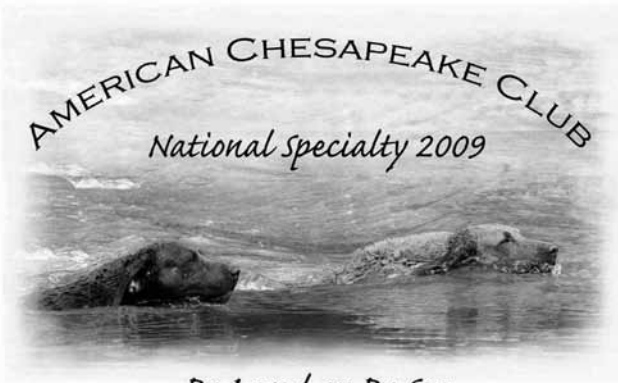

Amateur-Owner-Handler Class (effective as of 1/1/2009)

Chapter 3, Section 7 - The Amateur-Owner-Handler Class shall be for dogs that are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog. This class is restricted to exhibitors who have not, at any point in time, been a professional dog handler, AKC approved conformation judge, or employed as an assistant to a professional handler. Additionally, members of the immediate family or household of a current professional handler are ineligible for this class (as defined in Chapter 11, Section 13).

NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES

NR1.08100.24200. Veteran Classes - Class for dogs & class for bitches eight (8) years old & under 10 years. **Entry fee is \$18.00 as a first entry & \$6.00 as an additional entry.**

NR1.08100.37100. Veteran Classes - Class for dogs & class for bitches 10 years old & over. **Entry fee is \$18.00 as a first entry & \$6.00 as an additional entry.**

NR1.08200. Hunting Classes - Open to Chesapeake Bay Retriever dogs or bitches that has earned an AKC Junior, Senior or Master Hunter title. Sexes divided. **Entry fee is \$18.00 as a first entry & \$6.00 as an additional entry.**

NR1.08500. Field Trial Classes - Open to Chesapeake Bay Retriever dogs or bitches that has received a JAM or better at an AKC licensed or member field trial. Sexes divided. **Entry fee is \$18.00 as a first entry & \$6.00 as an additional entry.**

00900. BEST OF BREED COMPETITION

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

NR2.09100. Stud Dog Class - For Stud Dogs and two of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of Stud Dog need not necessarily be owner of Get. Get only to be judged based on the merits of the Get. Get MUST be entered in one of the Regular Classes. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the standard for its breed. **Entry fee is \$18.00 as a first entry & \$6.00 as an additional entry.**

NR2.09200. Brood Bitch Class - Same as Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get. As the judges' decision in the Stud Dog and Brood Bitch Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed by virtue of having won these classes.

NR2.09300. Brace Class - Two Dogs of the same breed and must have at least one common owner and presented by a maximum of two handlers. If more than one Brace is entered by the same owner, the dogs comprising each Brace must be so designated, "Brace no. 1," "Brace no. 2" etc. **Entry fee is \$18.00 per unit as a first entry & \$6.00 per unit as an additional entry.**

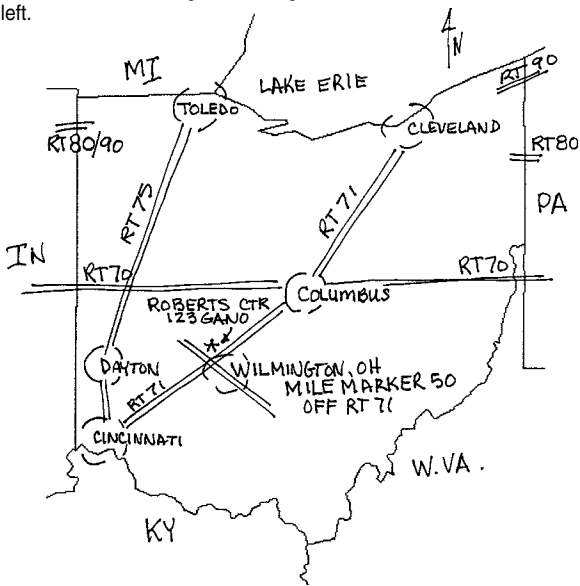

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
